JustZaap is committed to protecting your privacy. This Statement of Privacy applies to JustZaap app and governs data collection and usage. By using the JustZaap app, you consent to the data practices described in this statement.

Collection of your Personal Information

JustZaap collects personally identifiable information, such as your email address, name, work address and/or telephone number. This is available to us only when you've volunteered it.

There is also information about your mobile hardware and software that is automatically collected by JustZaap. This information can include: your mobile number, your device ID, device type, app installation ID. This information is used by JustZaap for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the JustZaap app.

In the event that you contact us for customer support through the app, we may also request that you provide additional User Information relevant to the support requested by you. Users are under no obligation to provide such information. However, we cannot guarantee that we can provide customer support in the event that relevant information related to the use of our products or services is withheld. We may retain communications relating to customer support, and/or information drawn from such communications, for statistical and/or reference purposes.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through JustZaap public message boards or forums, this information may be collected and used by others. Note: JustZaap does not read your private online communications with others.

JustZaap encourages you to review the privacy statements of apps you choose to link to from JustZaap so that you can understand how those apps collect, use and share your information. JustZaap is not responsible for the privacy statements or other content on apps outside of the JustZaap Private Limited apps or the use of your information by such outside apps.

Use of your Personal Information

JustZaap collects and uses your personal information to operate the JustZaap app and deliver the services you have requested. JustZaap may also use your personally identifiable information to inform you of other products or services available from JustZaap and its affiliates. JustZaap may also contact you via surveys to conduct research about your opinion of current services or of potential new services.

JustZaap does not sell, rent or lease its customer lists to third parties. JustZaap may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (email, name, address, telephone number) is not transferred to the third party. In addition, JustZaap may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. Such third parties are prohibited from using your personal information except to provide these services to JustZaap, and they are required to maintain the confidentiality of your information.

JustZaap does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

JustZaap keeps track of the apps and pages you visit within the JustZaap Private Limited family of apps, in order to determine what JustZaap services are the most popular. This data is

used to deliver customized content and advertising within JustZaap to customers whose behavior indicates that they are interested in a particular subject area.

JustZaap Private Limited will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on JustZaap or the site; (b) protect and defend the rights or properties of JustZaap Private Limited (including enforcing this agreement); and, (c) act under exigent circumstances to protect the personal safety of users of JustZaap, or the public.

If you provide JustZaap with user information, you have the following rights with respect to that information:

- To review the user information that you have supplied to us
- To request that we correct any errors, outdated information, or omissions in user information that you have supplied to us
- To request that your user information not be used to contact you
- To request that your user information be removed from any solicitation list that we use
- To request that your user information be deleted from our records and
- To opt out of being solicited by this app or third parties

If you request that your user information be deleted from our records, there may be a brief delay in our processing that request, while verify that the request is valid and originates from you as opposed to an unauthorized third party.
